

Resolution No. 31/514/21
of the Supervisory Board of KDPW_CCP S.A.
dated 29 June 2021

Pursuant to § 124 of the Rules of Transaction Clearing (Non-organised Trading), the KDPW_CCP S.A. Supervisory Board acting on request of the KDPW_CCP S.A. Management Board resolves as follows:

§ 1

§ 1 of Resolution No. 11/494/21 of the KDPW_CCP S.A. Supervisory Board dated 29 March 2021 shall be amended as follows:

“§ 1

1. Subject to sub-para. 2, the fee for management and administration of assets which are securities paid in as contributions to the OTC guarantee fund and posted as margins, referred to in item 5.1 of the Table of Fees in Appendix 1 to the Rules of Transaction Clearing (Non-organised Trading), shall be reduced for a fixed period of time in such a way that the fee shall be equal to 0.05% multiplied by the base used for the calculation of the fee in the given quarter.

2. The fee reduction referred to in sub-para. 1 shall apply for a fixed period of time, from 1 January 2021 to 31 December 2021, inclusive.”.

§ 2

This Resolution shall come into force on the date of adoption.
